Composition: Acrylic copolymer, water.

Hazardous ingredient(s): None of the ingredients of this product are classified as hazardous. Refer to Section 8 for Occupational Exposure Limits.

EXPOSURE CONTROLS AND PERSONAL PROTECTION

Ingestion: Prevent eating, drinking or smoking in the area of product use.

Eye contact: Safety glasses/goggles.

Skin contact: Protective gloves. (e.g. PVC)

Respiratory protection: In case of insufficient ventilation wear suitable equipment. Change contaminated clothing and clean before re-use.

Engineering controls: No specific ventilation requirement noted.

Exposure guidelines: None assigned.

FIRST AID MEASURES

Eyes: Irrigate immediately with copious quantities of water for 15 minutes. Obtain medical attention if irritation persists.

STABILITY AND REACTIVITY

Stability: Stable.

Conditions to Avoid: Temperature below 2°C

Flash Point (Closed Cup): None.

Extinguishing Media: Carbon dioxide, powder, foam or water fog – Do not use water jets.

Special Exposure Hazards: Material can splatter above 100°C. Polymer film can burn. Irritant fumes.

ACCIDENTAL RELEASE MEASURES

Personal Precautions: Wear suitable protective clothing, gloves and eye/face protection. Mixed with component A, the mixture can be irritating to the eyes and skin.

Health Effects

On Eyes: May cause transient irritation.
